By-Law Number 2024-066

A By-Law to amend By-Law 2022-040 being a By-Law to implement an Administrative Monetary Penalty System

Whereas the Township has approved By-law Number 2022-040, which establishes an administrative monetary penalty system for by-law offences, in accordance with Section 102.1 of the *Municipal Act, 2001,* and O. Reg. 333/07;

And Whereas the Township wishes to amend By-law 2022-040 to incorporate the addition of Clean Yards, Fireworks, Fence, Road Occupancy, Noise, Parks, Property Standards and Sign penalties for the purpose of using the Administrative Monetary Penalty System for enforcing the Bylaws;

Now Therefore the Council of The Corporation of the Township of King enacts as follows:
