By-Law Number 2025-009

A By-Law to Amend By-Law Number 2012-075 Being a By-Law to Licence Kennels and Doggie Daycares

Whereas Section 151(1) of the *Municipal Act, 2001 S.O. 2001*, c.25, as amended, authorizes Council of a local municipality to pass by-laws for licensing, regulating and governing any business carried on within the municipality; and

Whereas Section 10(2) 9 of the *Municipal Act, 2001 S.O. 2001*, c.25, as amended, permits Council of a local municipality to enact by-laws respecting animals; and

Whereas Section 10(2) 11 of the Municipal Act, 2001 S.O.2001, c.25, as amended, permits Council of a local municipality to enact by-laws respecting business licensing; and

Whereas Section 11(2) 8 of the *Municipal Act, 2001 S.O. 2001,c.25,* as amended, authorizes Council of a local municipality to enact by-laws respecting the protection of persons and property, including consumer protection; and

Whereas Council had adopted By-law Number 2012-075 for the purposes of licensing kennels and doggie daycares on December 12, 2012; and

Whereas Council deems it desirable to amend By-law Number 2012-075 to make the by-law consistent with the Township's zoning by-laws;

Now Therefore the Council of the Corporation of the Township of King hereby amends By-law 2012-075 as follows:

- 1. Part 1, Section aa definition of "Zone" be removed;
- 2. Part 2, Section 9 be amended to remove:

"In the case of a conflict with the zoning-by-law, this by-law shall prevail."

- 3. Part 6, Section 25 be repealed in its entirety and replaced with the following:
 - 25. In addition to the licensing requirements set out herein, every person who applies for a licence to operate a kennel, shall comply with the provisions of the applicable zoning by-law.
- 4. Part 6, Section 27, Subsection b. be amended to read:
 - b. The Kennel shall have a concrete or other impermeable floor drain opening, constructed as a plumbing fixture.
- 5. Part 6, Section 27, be amended to add new section after Subsection e.:
 - f. should the dog(s) or other animal(s) be kept in a cage, the cage shall be adequately sized and constructed solely of metal or wire or partly of metal and partly of wire and having a metal or other impermeable bottom.
- 6. Part 9, Section 29 be repealed in its entirety and replaced with the following:
 - 29. In addition to the licensing requirements set out herein, every person who applies for a licence to operate a doggie daycare, shall comply with the provisions of the applicable zoning by-law.

Read a **First** and **Second** time this 17th day of March 2025.

Read a Third time and finally passed this 17th day of March 2025.
