Paul Kulyk, Senior Planner, provided a slide presentation overview of the application commenting on: the site location, the proposed application and background, the site plan, the 'Our King' Official Plan designation, zoning provisions, building elevations, and staff's comments.

Tim Cane, SGL Planning, and Brian Henshaw, Beacon Environmental, spoke on behalf of the applicant and provided a slide presentation commenting on: the subject lands location, an overview of the proposed site plan, the proposed draft plan of subdivision, the draft Zoning By-law amendment, the 30m boundary buffer, environmental features, bat habitat in the area, and next steps in the process.
