*	<b>Bitten; or</b> (means the puncture of skin with teeth or means the breaking, puncturing or bruising of skin of a person or domestic animal caused by the tooth or teeth of a dog, and "bitten" has a corresponding meaning.)
	<b>Menacing</b> (means a dog that, without provocation, has approached or chased any person or domestic animal in a menacing, dangerous and threatening, fashion with an apparent attitude of attack, including but not limited to aggressive behaviours such as growling or snarling, or a dog that has otherwise demonstrated a propensity or disposition to attack without provocation, persons or domestic animals. )

Namely THAT on August 16, 2024, an incident involving 'Bear', a Black and Tan German Shepherd was being walked on a leash, but not under control by your daughter Senna, near 225 Patricia Dr King ON. "Bear" did engage in menacing behavior, leading to an unprovoked bite that resulted in injury to a person

These actions are deemed to be a violation under **Township of King By-law # 2016-85, section 5.2.**

## METHOD OF RESTRAINING/CONTROLLING SAID DOG

1. *Keep a muzzle on the dog at all times when off the premises of the owner.*  
**"Muzzle" means a basket-style covering device of adequate strength over the mouth of a dog to prevent the dog from biting and the words "muzzled" and "muzzling" have a similar meaning.**
2. *Keep the dog restrained when it is on the premises of the owner so as to prevent the dog from going beyond the boundaries of the premises. (On a leash held onto by a person, or within a fenced enclosure or fenced yard, the said fence shall be of sufficient height and strength to adequately prevent the dog from escaping. In addition where a gate forms a part of the secured enclosure or fence, the gate shall have a self-closing, self-latching device, kept in good working order and remained locked.)*
3. *Be under the control of a person eighteen (18) years of age or older at all times.*
4. *Keep the dog on only certain portions of the premises of the owner; (Keep inside yard enclosure, or a fenced rear yard)*
5. *Only walk the dog on a leash of not more than 6 feet in length;*
6. *Have a microchip implanted in the dog and proof of the implantation provided to the Officer (within 30 days of receipt of this order)*
7. *Provide an immunization record of the dog to the Officer;*
8. *Have the dog Sterilized (within 30 days of receipt of this order) and proof provided to the Officer,*
9. *Post a "Beware of Dog" sign at the entrance of the premises of the owner in a conspicuous place;*
10. *Notify the Officer/Clerk within 48 hours of any changes to the residency or ownership of the dog;*
11. *Notify the Officer/Clerk within 48 hours of the death of the dog; and*
