Notice of Intent

Take notice that the Council of the Township of King, at its meeting on June 17, 2024, intends to pass a resolution to stop train whistling at the following public grade crossings:

- Station Road;
- Dufferin Street at Mile 24.60; and.
- 15th Sideroad at Mile 26.10.

Train whistling is used to keep drivers, cyclists, and pedestrians safe when crossing the railroad tracks. In some cases, these whistles can be bothersome to people living nearby, and municipalities can consult and collaborate with the railway company to stop train whistling at a public grade crossing to provide residents with relief from the noise.

The resolution is intended to stop the sounding of a whistle or horn when a train approaches the public grade crossings listed above. It is anticipated the whistle or horn will not be activated on a regular basis but may be necessary in the case of any immediate safety concerns.
