The HAC asked about cemetery sign and whether it was recognized as a heritage attribute and if it was part of this heritage designation.

Staff noted that it was not part of the heritage designation but it is an element that will need to address as part of the repair and restoration works.

Staff updated the HAC on the status of the research completed for the Barn located at 8580 19th Sideroad and that it was Staff's intention to explore the option of designating the barn on the Heritage Register.
